I understand that in any activity which involves the use of horses, there is an inherent risk of personal or bodily injury of property damage, as such animals are often temperamental and dangerous. In consideration of being afforded the opportunity to participate in this activity and use the equipment and facilities of the Prince Albert Exhibition Association (the operator), I agree as follows:

- a) To accept all risk of personal and bodily injury to myself; and
- b) To accept all risk and property damage to my equipment and/or to my horse; and
- c) To release, remise and discharge the operator, the Prince Albert Exhibition Association and their agents, servants, representatives, sponsors, employees, and officials from all liability, and any and all demands, claims, actions, or causes of action arising out of or in connection with my participation in this activity and the use of the said equipment and facilities, notwithstanding that such liability, claim, or action may have been occasioned or contributed to by the negligence of any of them; and that such release is and will continue to be binding on me, my heirs, executors, administrators, and assigns.
- d) To indemnify and save harmless the operator, the Prince Albert Exhibition Association, and their agents, servants, representatives, sponsors, employees, assigns, and officials from and against any claim of action against them arising out of my participation, even though the same may have been occasioned or contributed to by their negligence.

In the event that during the course of my participation in this activity, I am found to be a cause - the cause of a third party's property damage, I agree to indemnify and save the harmless operator, the Prince Albert Exhibition Association, and their agents, servants, representatives, sponsors, employees, and officials from any and all liability and any and all claims arising out of or in connection with my participation in the activity or the use of the operator and/or the Prince Albert Exhibition Association's equipment or facilities notwithstanding that such liability, claim or action may have been occasioned by or contributed to by the negligence of any of them.
