Commencing **September 3rd, 2020** and **terminating** as early as **April 15<sup>th</sup>, 2021** when we will begin notifying renters to remove their stored item. **Removal must be completed by April 30th, 2021**

Rental rates shall be **\$50.00** per month for units up to **20** feet, plus **\$2.00** per foot for units exceeding 20 feet. **This measurement is from bumper to bumper or hitch to prop**, whichever applies. GST will be added to this rate.

The **PRINCE ALBERT EXHIBITION ASSOCIATION** will attempt to meet the requests for removal of the units by the **RENTERS**, but failure to do so will not affect the rental charges. **Rent will be charged per month and per day for the full term of the storage.**

If the item stored is a boat and motor, the **RENTER** agrees that the gasoline tank will be removed from the boat at the time of storage and that all gasoline will be drained from the motor. All propane tanks are to be removed from camper trailers.

The **RENTER** further agrees that the **PRINCE ALBERT EXHIBITION ASSOCIATION** is in no way responsible for the safety of the stored item(s), nor is responsible for any damage incurred during the rental period.

**FOR THE ENTIRETY OF THIS AGREEMENT IT IS THE RESPONSIBILITY OF THE RENTER TO PROPERLY INSURE THE ITEM(S) BEING STORED. THE RENTER WILL BE REQUIRED, AS A CONDITION OF THIS AGREEMENT, TO PROVIDE THE PRINCE ALBERT EXHIBITION ASSOCIATION INC. WITH A CERTIFICATE OF INSURANCE, CONFIRMING THAT INSURANCE COVERAGE IS IN EFFECT FOR THE DURATION OF THE STORAGE PERIOD ON EACH AND EVERY ITEM BEING STORED.**
