**NOTICE OF REQUEST FOR EXPRESSION OF INTEREST
RFP No. 2023-RP02**

Prince Albert Exhibition Incorporation is looking to partner with a professional fireworks business to provide a fireworks grand finale show for the PAEX 2023 Summer Fair.

The Prince Albert Exhibition Incorporation will accept Proposals from OH&S certified, insured fireworks businesses. The fireworks business will be required to provide a Professional Outdoors Fireworks Show on the last day of the PAEX 2023 Summer Fair. The Fireworks Show to take place around 10:30 p.m. August 5th, 2023.

CRITERIA:

The PAEX expects the Fireworks Show to be a pyromusical format. Fireworks done to music. The exact location and details to be determined during the permitting process.

The Fireworks Show to last approx. 15 minutes. The fireworks business to recommend the music choices and to be reviewed by PAEX official prior to the Fireworks Show to confirm suitability. This can be achieved via e-mail or on a mutual agreed to meeting time.

The fireworks business to:

- 1) Obtain Fire Department permit;
- 2) Obtain Certificate of Insurance for \$5,000,000. And provide to PAEX;
- 3) Obtain approval from City of Prince Albert as it pertains to recent bylaw changes;
- 4) Be covered under OH&S;
- 5) Contact/notify Airport for approvals;
- 6) For safety reasons, monitor weather to determine if the Fireworks Show is a go;
- 7) Provide a complete sound system with enough speakers to saturate the immediate viewing area of the fireworks and erect an FM radio Transmitter 98.5 FM and be able to change the Frequency if this conflicts with any commercial broadcaster.
- 8) Bring own generator.
- 9) Other relevant equipment and tasks.

The PAEX would like to work with the fireworks business in partnership to determine that a portion of the cost be towards mutually agreed to advertising.

While we appreciate all those interested in performing the Professional Fireworks Show for the PAEX. We will only be contacting the successful business.
